MEETING MINUTES OF THE SPECIAL MEETING OF THE BOARD OF FIRE COMMISSIONERS OF THE WINFIELD FIRE PROTECTION DISTRICT

March 21, 2013

Meeting called to order by Chairman Levan at 5:00 p.m. at Station #1, 27W530 Highlake Road, Winfield, Illinois.

Roll Call: Chairman Chris Levan, Secretary George Kallas, Robb Hannen and Administrative Assistant Robin Youngberg.

<u>Minutes</u>: After minor revisions to the minutes, Commissioner Hannen made a motion to adopt the Special Meeting minutes of 10/1/12, 11/5/12, 1/19/13, and 2/26/13 as amended, seconded by Commissioner Kallas. Pursuant to voice vote, all in favor, motion carried.

Following the deadline for submitting CPAT and Ladder Climb Certifications, all candidates who failed to submit the required certifications were notified by Certified Mail that they were no long eligible to continue with the full-time firefighter testing process. The remaining candidates were also notified by Certified Mail that they successfully met all of the requirements to continue with the test and were informed of the date, time and place of their scheduled oral. A Preliminary Eligibility Register was prepared and posted, listing the eligible candidates by written score. Chairman Levan made a motion to ratify the Preliminary Eligibility Register effective Monday, 3/18/13, seconded by Commissioner Hannen. Pursuant to voice vote, all in favor, motion carried.

The Board Members individually reviewed a list of ten potential questions to pose to candidates during their oral interview. After discussion, Commissioner Kallas made a motion to use Questions 1, 4, 6, 9, and 10, seconded by Commissioner Hannen. Pursuant to voice vote, all in favor, motion carried. Robin Youngberg will prepare a new scoring sheet and question cards for the candidates to read from.
